

ASSUMPTION OF COVID-19 RISK AND RELEASE OF LIABILITY

St. Peters' Lutheran School ("the Business") has reopened to provide parents and/or legal guardians and their children (Participants) with child care services ("the Services") pursuant to applicable law at a time when exposure to and infection by the COVID-19 virus remains a risk for the Business's employees and participants alike. While the Business will do its best to maintain a clean and safe environment, it cannot guarantee that a Participant will not be exposed to or infected by the COVID-19 virus and/or other similar conditions (collectively, "the Virus"). The Business has posted guidelines based on government and professional recommendations to ensure best practices ("the Guidelines").

The Business is only willing to provide a participant with Services on the condition that the Participant (i.e. the Parent or Legal Guardian, individually, and on behalf of his/her minor child) a) represents that both he/she and his/her minor child is safe to provide Services upon, b) acknowledges the risks associated by engaging the Business's Services at this time, c) adheres to the Guidelines, and d) assumes all risk of exposure to and infection by the Virus while at the Business.

Therefore, in consideration for the foregoing, Participant (i.e. the Parent or Legal Guardian, individually, and on behalf of his/her minor child) hereby represents, acknowledges, and agrees that he/she and his/her minor child:

1. Is not infected with the Virus and has not been in contact with anyone who has contracted the Virus within the last fourteen (14) days.
2. Has not experienced any symptoms associated with the Virus within the last fourteen (14) days, including fever, chills, loss of appetite, smell, or taste, headaches, and the like.
3. Agrees to take reasonable measures to protect him/herself and his/her minor child from exposure to the Virus while at the Business, including following the Business's Guidelines.
4. Understands that, despite the Business's best practices, the Business cannot guarantee the safety of its participants or that its premises are Virus-free, and that the risk of being exposed to and contracting the Virus while engaged in close-contact activity at the Business is real and actual.
5. Assumes all risk of exposure to and infection by the Virus, and accepts sole responsibility for and any illness, injury, death, expense, loss, or other damage experienced by him/herself and/or his/her minor child as the result of being exposed to or infected by the Virus ("Claims"), even if such Claims arise out of the Business's or its employees' own negligence.
6. Agrees not to sue, and forever releases, discharges, and holds harmless the Business, its officers, agents, representatives, and employees/independent contractors from any and all Claims arising out of or related to my voluntary engagement of the Business's Services.
